## 1. MINUTES OF THE PREVIOUS MEETING

### 3. STRATEGIC PLAN WITH REFERENCE TO RACE OFFICIALS

The committee received a progress report on the implementation of the Strategic Plan projects from the chairman and the Competitions Manager. It was noted that the committee provided solutions to all items referred to the ROC and some items have separate headers in the agenda of today's meeting.

#### 4. TECHNOLOGY WORKING PARTY

The Chairman of the Technology Working Party gave a report on the implementation of on line tracking systems to the Race Officials Committees. Parts of the report were received during the closed session at the end of the meeting.

It was noted that the members of the ROC did not report any conflict of interest.

It was felt that the development and implementation of an on line tracking system with OCS detection is one of the most important projects for the race officials area. There are currently over 100 different systems available world wide but many of them operate with different standards.

It was felt that it is necessary to define an official standard endorsed by ISAF so that program developers can adjust their systems accordingly and that every effort should be made to have these standards available by mid 2009.

The committee thanked the chairman and the members of the working party for their contribution and recommended to the next Race Officials Committee to reappoint this working party.

#### Recommendation to Council:

The Committee supports the work done by the Technology Working Party with regard to Online Tracking Systems and recommends the continuing of the working party. The Committee strongly recommends to the Executive Committee to progress the plans to adopt a specification to enable standardization of tracking systems and to implement an online tracking system endorsed by ISAF for the ISAF World Cup. ISAF should adopt a policy of ownership of the data generated and stored within a tracking system.

### 6. INTERNATIONAL CLASSIFIERS

### (a) Submission 131-08

The committee discussed and considered submission 131-08 from the Chairman of the Race Officials Committee about the implementation of International Classifiers.

The committee supported the introduction of International Classifiers but it was felt that the introduction of International Classifiers will need more time to ensure that the relevant practices are in place.

### Recommendation to Council:

Defer Submission 131-08

Race Officials Committee will continue to work with IFDS Classifiers to align the practices of both parties where appropriate.

# (b) Strategy to implement International Classifiers

The committee noted that the implementation of International Classifiers into the ISAF Race Officials is work in progress.

### 7. ROC BUDGET

### (a) Expenditure 2008

The committee noted the expenditure for the period November 2007 to date. The committee spent GBP 69.000 for training and development of race officials. The most expensive item on the expenditure was the organising of the first Race Officials Instructors Conference in Southampton from 3-5 October 2008.

### (b) <u>Budget 2009</u>

The committee noted the proposed budget for 2009. Apart from the ongoing work with Seminar and Clinics, provisions should be made for the production of a new RRS 42 video material. A provision should be made for the expenditure of the Technology in Sailing Working Party, if appointed again.

### 8. PAYMENTS TO RACE OFFICIALS

It was noted that these proposed fees will not be implemented before a 12 months notice to event organisers.

The committee felt that once appointed as an International Race Official an individual is required to act independently of his MNA and so it is not appropriate for a re-application to require MNA support. It was noted that MNAs are informed of any applications for re-appointment and are invited to comment.

## 10. RECOGNIZED RACE OFFICIALS

The committee felt there were merits in the proposal and that helping race officials from developing regions to become International Race Officials should remain a priority for the Race Officials Committee.

### 12. DESIGNATED MNA OF RACE OFFICALS

The committee received a report from the Competitions Manager on the status of Race Officials under the exemptions of regulation 35. It was noted that the system is working well and only one candidate for first appointment is affected in 2008.

### 13. CONFLICTS OF INTEREST

### (a) Guidelines for the assessments

The committee discussed the draft guidelines to assess conflicts of interest as produced by the chairman. It was understood that this is work in progress and will need regularly updating.

The committee supported the document in principle.

## (b) Conflicts of Interest received

The committee noted the three requests from International Race Officials under Regulation 50 to assess possible conflicts of interest were received in 2008.

#### 14. MAJOR EVENTS

### (a) Olympic Sailing Competition

The committee received a verbal report about the Olympic Sailing Competition 2008 in Qingdao from the chairman of the International Jury. The ISAF race officials played a significant role for the success of the event. The committee thanked all the race officials for their contribution.

It was noted that the harmonization of event documents are vital for the success of the event and group to review all relevant documents should be appointed beforehand.

# (b) Olympic Jury

It was felt that the quality of the composition of the Olympic Juries in previous Olympic Sailing Competitions were of exceptional high quality and that the submission would probably decrease the level of quality.

# (d) Volvo Ocean Race 2008-2009

The committee received a verbal report from the chairman about the Volvo Ocean Race 2008-2009.

Some concerns regarding the practicality of email jury were noted.

# (e) Other Major Events

(i) Development of medal race formats.

The committee felt that the medal format worked very well for the Olympic Sailing Competition and further development of the format will be necessary if this format remains at the Olympic level.

(ii) ISAF World Cup

The committee received an update report from the ISAF Events Manager on the preparations for the ISAF World Cup.

### 15. RACE OFFICIALS REPORTING SYSTEM

### (a) Regatta Report Forms

The committee noted that the same regatta report forms were used as in previous years.

# (b) Summary of Reports Received

The committee received a report about the report received. Only the minority of reports are containing useful information.

### (c) Online Reporting System

The On line Reporting system is still work in progress. This system should in place for trials in 2009 and should be used for application for status as well. It was noted that there is already a website available where a judge can upload his event reports. The use of the website (<a href="www.ijreport.org">www.ijreport.org</a>) should be encouraged until the on line reporting system will be completed.

#### 16. RACE OFFICIALS CONFERENCE

## (a) ISAF Seminar Instructors Conference 2008

The chairman gave a report on the first ISAF Seminar Instructor Conference held in Southampton, UK from 3-5 October 2008. Over 90 percent of all ISAF instructors and some candidates attended the conference.

Main topics were the review of the seminar and clinic materials, the implementation of e-learning tools and need to develop standard for fair play and rules compliance over the disciplines.

In addition, the development of a code of conduct for both race officials and seminar instructors was felt to be an important target.

# (b) Future Conferences

The committee felt that there is no need to organise a Race Officials Conference in 2009 but an overall plan should be established to enable each discipline to run such a conference once every four years.

#### 17. RACE OFFICIALS SEMINAR / CLINIC PROGRAMME

### (a) Seminar and Clinic Programme

The committee noted the success of the Race Officials Seminar and Clinic Programme in 2008.

### (b) Clinics in Association with ISAF Events

The committee was informed that Match Racing and Umpiring Clinics were organised in conjunction with the ISAF Nations Cup 2009 Regional Finals.

# (c) Clinics and Seminars in Association with Regional Games

The committee identified the following Regional Games in 2009 where Clinics and Seminars should take place:

- Pan Am Games

### (d) Clinic / Seminar Material

The seminar/ clinic material across the disciplines was reviewed during the Race Officials Instructor Conference in 2008.

The main changes are one single structure for all Manuals regardless of the discipline with the possibility of hyperlinks. The Race Management Manual will change the format back to plain text.

### (a) Updates to Manuals

The chairman reported that all manuals are currently under review to restructure them to a single standard. This will allow the composition of manuals specific to the need of the individual.

All Manuals were currently updated to reflect the new rules.

### (b) Policy Regarding Publication of RO Manuals and Publications

All ISAF race officials will receive the following publications in 2009: a copy of the Racing Rules of Sailing 2009 – 2012; a copy of the Equipment Rules of Sailing 2009 – 2012; an updated version of the Race Officials CD-ROM with all manuals, the rules book, the case book, the call book, all relevant forms and other useful information.

The Sub-committees will advice the Secretariat how they prefer to have their documents structured in the ISAF website. Such structure needs to be consistent within the whole website.

# (c) National Race Officials Materials

National Race Officials Materials are currently developed for both Judges and Umpires. The IJSC is about to finalize their national kits and to identify individual regional coordinators. They will attend one international work shop and should be able to deliver the material to the national race officials in a specific region.

It is planned that the NJ kit will be translated into different languages, starting with Spanish and Portuguese.
