## 1. Opening of the Meeting

The Chairman welcomed everyone to the first meeting of the new Constitution Committee, and summarised the activities that the Committee, its working Parties, and as Chairman he had undertaken over the last twelve months, including his reports to the Executive in May and

September and the presentation he had, at short notice made to Council in May., and advice given both to Chairmen of other Committees and to the Secretary general. He also reminded members of the obligations under Regulation 6.4.3, and the need to disclose any possible conflicts of interest. He in particular disclosed his previous involvement with ORC.

Stanislav Kassarov and Balazs Hajdu disclosed potential conflict of interest in some issues concerning the Olympic classes due to their involvement as International 470 Class President and International Finn Class President respectively.

## 2. Minutes of the Previous Meeting

Professional arm of the sport of Sailing

The Chairman highlighted the issue that the professional arm of our sport is developing fast and needs professional services from ISAF, for example Rules, Judges, Umpires, Measurement, Safety, Anti-Doping but that it was crucial not to forget those who sail or race for pure pleasure. The approach for these two areas may have to be different and therefore will need to be looked at by the Constitution Committee

ISAF Structure and Governance

On request from the Executive Committee, a Working Party led by Philip Tolhurst, Chairman of the Constitution Committee had undertaken a review of the ISAF structure and governance.

The Chairman summarised the structures of other Summer Federations in comparison to that of ISAF. It was evident that some areas require review but this should be consistent with the goals and objectives of ISAF. In particular the Regulations should be consistent with the Constitution and internationally understood.

#### 6. ISAF Governance

(a) The paper from the working party (please see Appendix A) was distributed.

The Chairman explained the context in which this review was taking place and its objectives.

The publication of a directive from the Olympic Congress on Good Governance was noted and it was concluded that until it was clear as to the actual requirements of the IOC we could not continue to discuss this. Currently those requirements are being reviewed and once that has been done the Working party will review whether ISAF currently meet the IOC requirements.

Further the review had to be within the context of the Strategic Plan, the draft of which would be published at the meeting of Council.

However three matters raised by the working party were already within the scope of submissions, leaving a further 14 papers under discussion.

For the reasons above The Chairman proposed that that this work be deferred, with the exception of two particular items.

**Working Party Paper – Item 5** - Outstanding request under Regulation 3 as to the process for the election of Committee Members (Reg 6.2.5)

At present every 4 years concurrent with the General Assembly individuals are nominated by MNAs for different ISAF committees (except the Audit Committee) pursuant to Regulation 6.1 (a).

Subsequently, before 60 days have elapsed since the date of the General Assembly, the new Executive Committee recommends to the Council the appointments of Chairmen, Vice Chairmen and members of the ISAF Committees (Regulation 6.2.4, Article 69) for the next 4 year period bearing in mind the guidelines set forth in Regulation 6.2.2.

This arrangement creates a situation where a "vacuum" occurs between the time the old ISAF Committees are disbanded before the General Assembly in November, and the new ISAF Committees are appointed some time after the General Assembly. At the earliest this will be the following January.

In addition, it is unclear whether a Council member appointed in the position of Chairman of the Classes or Offshore Committees or as Women's Representative, can also vote on the new appointments, and further whether that should be the outgoing or new chairman or representative if there is a change at that time.

A Working party consisting of: John Crebbin, Jon Napier, Scott Perry and Fernando Pombo was appointed to look at this issue.

## **Appendix B - Item 6 - Ideas** on Changes to the Submission Process

The second issue the Chairman asked the Committee to consider was possible changes in Regulations to improve the Submission Process. The Chairman submitted a paper (attached as Appendix B) which detailed some personal thoughts.

The following comments were made:

- A great deal of our Business is enshrined by Regulation, which would explain why we are so often in a situation where we receive proposals in the form of a change to Regulations. It was felt that we are overly driven by the formality of Regulations, but that formality also acts as an appropriate restriction in certain cases It is very difficult to distinguish between housekeeping and substantive changes, and different countries often see one as the other.
- The question was asked whether we should instead move in the direction of reviewing the formality behind the process.
- Some Countries are daunted by the process and it had been suggested that perhaps some assistance could be given prior to the submission. The Secretary General expressed concern on this idea based on the fact that if it's rejected the onus comes back on the committee, or person, that assisted in the drafting. Conversely informal assistance had in the past and could in future help.
- Decision: The (review) Working party consisting of: the Chairman, John Crebbin, Jon Napier, and Scott Perry, to which Fernando Pombo was also added, were re-appointed, and asked to proceed with a review of these particular ideas independently of the more general review.

The reporting committee, the Executive, will liaise with the Constitution Committee as per Regulation 15.3.6 (g).

It is envisaged that the detailed proposals to amend the Articles shall be presented to Council in May 2010 for final approval by the AGM of all members in November 2010.

The Chairman confirmed that last year the Constitution Committee had recommended that the Federation Libanaise de Yachting be moved from Group D to Group I. It transpired that this however had not previously been discussed with Lebanon, and subsequently they objected. The objection still remains.

Jack Caldwell confirmed he would send previous notes in regard to this agenda item to the Constitution Committee

(e) Challenge to Existing Membership

The Federacion Paraguaya de Vela (FEPAVE) is challenging the status of the Yacht Club Ypacarai (YPY) as Paraguay's MNA before ISAF. As evidence and backup for its challenge FEPAVE submitted letters of support from various Paraguayan sports authorities.

After consideration the Constitution Committee decided to postpone its decision on this challenge for 1 year to give the parties, FEPAVE and the YCY, a chance to reach an amicable arrangement or solution.

#### 16. International Hobie Class Association Vote at ICC

The International Hobie Class Association wishes to clarify the voting situation at the International Classes Committee under ISAF Regulation 3.2.

The International Hobie Class Association has six ISAF Classes (Hobie 14,16,17,18, Tiger and Dragoon) and as such has six votes at the ICC. There is on occasion's only one Hobie representative at the ICC. At the recent ISAF Conference the question was raised if one delegate could hold votes for more than one class., the concern being that one person could get a group of proxies and sway the voting. The individual did not have proxies as he was the Executive Director of the Hobie Class, and his name is listed as the contact for all the Hobie Classes

#### **Decision**

The Committee confirmed that each ISAF class has the right to sit at the Classes committee, and therefore, if the Hobie Class wish to have six votes, then six individual people need to attend.

## 17. Annual Report

The Committee authorised the Chairman to finalise, in liaison with the Vice Chairman, the Committee's report to the ISAF Council meeting of 12 November 2009 on the activities of the Constitution Committee for the period of 1 January 2009 to Date.

## 18. Any Other Business

## **Communication within the Constitution Committee**

The Committee discussed on how to improve effective communication within the Committee between meetings. A suggestion was made to look at some kind of a private online forum type software that can be very helpful discussing subjects. The Secretary General agreed to look into to this.

The Secretary General further proposed that mail shots to the Committee should be send through the Secretariat to ensure the latest email addresses of members are used.

#### **Rule 69 Cases**

The Chairman informed that the Constitution Committee has been formally asked to look at the processes involved in the event of a Rule 69 case instigated by ISAF, as a consequence of a sailor making an incorrect application under the Classification Code. Following a review of the relevant regulations and rules, an outline proposal will be worked on by a Working Party of four members of the Committee. The Working Party will consist of: Lorenz Walch, Philip Tolhurst, Tom Schubert and Peter Hall.

The Executive and the Race Officials committee will also be asked to nominate people to join this Working Party. There is a need to establish this as soon as possible.

#### **Conflict of Interest Working Party**

The Chairman confirmed there was previously and remains a working party reviewing the "issue" of potential "Conflicts of Interests". An interim report had been prepared, however it was suggested that the Committee should now be liaising with the Race Officials Committee before producing a final report. # **Appendix B**

## Item 6

## Ideas on Changes to Submission Process

- 1. Comments made in May gave a clear demonstration that the present procedure is rather daunting for some countries, leads to some submission being poorly drafted, and in some case both the purpose ie. Objective of the submission and the reasons are not clearly articulated or become confused.
- 2. The objective and the reasons supporting a submission are frequently distinctly different and therefore should be clearly separated
- 3. Reg. I, although headed 'Notices and Submission' also at various places refers to 'proposals' but gives no separate indication of how a proposal differs from a submission although the test clearly anticipates that can be made and they can be dealt with differently.
- 4. It would also assist Council if submission were more clearly differentiated between Housekeeping, minor and those involving a policy change. Some submission are already dealt with by committee Could that be expanded to include "Housekeeping" and possibly "Minor" and presented to council simply for ratification 'en bloc', but with the ability of council to call for any particular submission decision to be individually reviewed.
- **5.** As to format this might be improved if the submitter first set out the objective or purpose of his submission, then the background and then the submission and lastly the reasons.
- 6. If we could clarify the procedure for proposals then the MNA's etc could be asked to 'submit' these at any time: Could technology then enable these 'ideas' to be posted on the MNA are of the website and for a 'chat room debate' to allow feedback before the proposal moves to a formal submission?
- 7. Do we also need to review the process by which submissions are considered can it be improved upon?
  - Can we have a better way of amending without changing the intent ie purpose?
- **8.** Should the current provisions dealing with the CC post conference review be improved upon or even expanded?
