- 49.2 The membership of the Women's Forum shall consist of the following:
 - (a) <u>a Chairman who shall be the women's representative on the Council from time to time;</u>
 - (b) <u>all women who are from time to time members of ISAF Committees and Sub-committees; and</u>
 - (c) an additional six women each of them representing one of the six

 Continents as defined in these Regulations, such women to be nominated and appointed as provided in Regulation 6 as if they were being nominated and appointed as committee members except that Regulation 6.2.2 shall not apply.

Current Position:

There is no provision of this nature at present.

Reason:

This submission is also made pursuant to the resolution of Council at the mid-year meeting in May 2007, recorded under minute 10(d) of that meeting.

EXECUTIVE COMMITTEE RECOMMENDATION – FEBRUARY 2008

The Executive Committee recommends rejecting this submission as it felt this requirement is not necessary and is very difficult to implement. If suitable women candidates are available they should be made members of ISAF Committees and therefore automatically become members of the Forum.
