Proposal

To adopt the VIPER Class as an ISAF Recognised class.

Current Position

Reason

The Viper class is a 16ft high performance catamaran racing actively across four continents, 15 countries and boasting 110 boats. The Viper Class has been created as a strict one-design catamaran where the true test when raced is between crews and not boats and equipment. The Viper is designed for a large weight range and encourages Women's, mixed, youth and men's teams to compete equally on high performance multihull equipment.

The Viper is now just over two years old and the growth has been outstanding. The Viper fleets originated from Australia with the manufacturer based in Bendigo, Australia. Currently there are 24 boats racing in Australia, 21 boats in the USA. In 2010 the fleets in Europe are booming with 25 boats in France alone. Asia is a growth area for the Viper with 15 boats this year.

The Viper just recently finished top six in the F16 Euro Challenge. Five of the six top teams had a female crew member and of that four of the six had crew members under 20 years old.

The Viper was used as supplied equipment for the 2009 Alter Cup in the United States of America.

A formal application was made to the Secretary General on 31st July 2010 in accordance with ISAF regulations 26.

ISAF Regulation 26.2.1.

- (a) Active Class/Owner Association
 - The VIPER has an active owner run association with a class race program shown by a dedicated series of events.
- (b) <u>Class Constitution</u>
 - The VIPER class has been managed from its initial conception by the owners' association. The VIPER Class Association has adopted a formal constitution.

 - Class rules have been established by the class and are meeting ISAF standards using the ISAF standard class rules as a model in consultation with the ISAF Secretariat.
