EUROSAF has confirmed that they intend to include the Paralympic Fleets in future events, however the event taking place in Valencia will be restricted to sailors with an IFDS International Classification.

Registrations to participate in the event have been received from Malaysia, Hong Kong and expressions of interests have been received from Japan, Korea
