Minutes of the Previous Meeting

(a) Minutes

> The minutes of the IFDS Executive & Committee Chairs meeting of 21 July 2009 were noted and approved.

(b) Minutes Matters Arising

> The appointment of Chairs to the IFDS Events & Scheduling Commission and the Development Committee are still being discussed.

2. **IFDS Committee/Commission Reports**

IFDS Coaches Commission

The Chair of the IFDS Coaches Commission, Betsy Alison confirmed that National team coaches and sailors had been questioned and the overwhelming preference is for the Paralympic Sailing Competition to comprise of 6 racing days with 2 races per day and no reserve day. Also that Sonar's and 2.4mR's should sail a Windward Leeward course and not a trapezoid course.

Decision

The IFDS Executive Committee will convey this to LOCOG and IPC.

(b) IFDS Events & Scheduling Commission

It was confirmed that the accommodation facilities in Medemblik will be €700-900 per week per cabin which consists of 4-6 beds. These units are currently being inspected on their accessibility and the accommodation will be allocated according to the access needs of the athletes.

The jury members for this event have been identified as Lynne Beal, Guido Piessens, Costas Tsantilis, Henry Sleutel and Hugh Elliot. The Chairs of this committee is still to be identified.

It was noted that the Organizing Authority will not accept credit card payment for entry fees, however they will accept a bank transfer or payment at the venue.

The Organizing Authority has agreed that a Sonar training camp may be held at the venue in May and will be advising venue fees.

There is concern from the Organizing Authority about the SKUD18 entry numbers, however it is expected a number of countries will attend as this is the first nations qualification opportunity.

(c) IFDS Fundraising Committee

This item was deferred until Item 3.

(d) IFDS Governance & Procedures Committee

This item was deferred until the next meeting.

(e) IFDS Measurement/Classes Committee

The report from the Chairman, Gene Hinkel which was circulated was discussed.

(f) IFDS Medical Committee

The Chairman of the IFDS Medical Committee summarized his report:

He had been contacted in order to carry out IFDS International Classifications in Barcelona, but this has since been cancelled.

Two IFDS International Classifiers will be attending the Semaine Olympique Française, Hyeres, France, so IFDS International Classifiers will be able to be carried out.

The application to ISAF for inclusion of classifiers as race officials may be stepped back as there is concern about loss of control of important aspects of the role.

Bernard Destrube and Jürgen Schwittai attended the IPC Classifiers Conference where it was confirmed that athletes with an intellectual disability were being re-introduced into some sports for the 2012 Paralympic Games. These events are being held separately and are using a minimum disability criteria.

(g) IFDS Sailors Advisory Council

With the absence of Hannah Stodel, it was confirmed that she had been working closely with the Weymouth & Portland Council regarding accommodation in Weymouth. A questionnaire has been prepared and this will be circulated shortly to all nations and athletes. The aim is to maximise the allocation of appropriately accessible facilities to the athletes who need them most.

(h) IFDS Technical Committee

It was noted that Hugh Elliot is contacting the Committee Members to discuss projects the group should be taking on.

One project identified is developing a guide for the safe retrieval of sailors with a disability who have gone overboard.

The adaptations database project now forms part of the METS-DAME website project.

The Race Management Manual is still being reviewed and this will be finalized for confirmed at the 24 March IFDS Executive Committee Telephone Meeting. Once confirmed this manual will be published.

3. IFDS Finance

(a) IFDS Finances

It was noted that the 2009 Income and Expenditure will be finalized shortly in order to present the accounts for audit.

(b) RNA Subscriptions

John Twomey reported that the 2010 RNA Subscriptions have been requested from RNA's along with any outstanding amounts.

Concern was raised about some RNA's not maintaining their subscriptions and this item will be discussed further during the Face-to-Face Meeting in Medemblik.

It was confirmed that details of the ISAF MNA fee structure had been circulated.

Decision

This will be re-circulated and it will be discussed further during the next IFDS Executive Committee Face-to-Face Meeting.

It was agreed that the Malaysia and the Philippines RNA's would be contacted and encouraged to maintain participation in IFDS events.

(a) Three Paralympic Classes, 2012, Fort Myers, USA

The proposal to hold an IFDS World Championship in Fort Myers, USA was discussed.

Decision

Some concerns were noted about this event and it was agreed that this will be investigated.

Henry Sleutel appointed as Technical Delegate for this event.

(b) 2010 Homerus Blind Match Racing, Italy

Details of this event were given and it was noted that the IFDS Technical Delegate, David Staley is in regular contact with the organizers. The event organizers are hoping to have 10 teams in the B1 division and another 10 teams shared across the B2 and B3 divisions.

(c) Three Paralympic Classes, 2015, Brazil

(d) Future IFDS Events

St Petersburg Yacht Club, USA has expressed an interest in hosting an IFDS World Championships in either 2014 or 2016.

It was agreed that the RNA's in the Asia-Pacific region would be contacted and encouraged to submit bids for 2013 and/or 2014.
