It was noted that Aruba Sailing Association, granted provisional membership at the Council Mid-Year Meeting 2009, has now fulfilled all constitutional requirements and was formally granted full membership in July 2010. Membership fees will be invoiced pro-rata.

#### ii) Botswana

It was noted that Botswana Yacht Racing Association, granted provisional membership at the Council Mid-Year Meeting 2010, has now fulfilled all constitutional requirements and was formally granted full membership in September 2010. Membership fees will be invoiced pro-rata.

## iii) Mozambique

It was noted that Mozambique Sailing and Canoeing Federation had been granted provisional membership at the Council Mid-Year Meeting 2010 subject to resolving a particular issue on their constitution.

Note: During the Council Meeting, that issue was satisfactorily resolved and MSCF having now fulfilled all constitutional requirements was formally granted full membership in November 2010.

# (c) Georgia

It was noted that the Executive Committee will make a recommendation to Council to cancel the Associate Membership of Georgia as they have failed to comply with their membership obligations in a material respect.

## **Decision**

Approve the recommendation to cancel the Associate Membership of the Georgian Sailing Federation.

# (d) Challenge to Existing Membership

A decision was made in November 2009 to allow another year to pass in order for the Federacion Paraguaya de Vela (FEPAVE) and the Yacht Club Ypacarai (YPY) to reach an amicable arrangement or solution. This has not been the case and further correspondence was received by the Secretary General. Most of the communications were in Spanish and the Chairman therefore asked Scott Perry to review the file and he gave a verbal report. There followed a detailed discussion and the positions of both parties were considered.

#### Decision

The Secretary General shall write to the Federacion Paraguaya de Vela (FEPAVE advising that ISAF cannot consider the challenge to the existing membership of the Yacht Club Ypacarai (YPY) as it does not meet the criteria detailed in the ISAF Constitution and Regulations.

# 9. To Consider the Ongoing Review of the Articles of Constitution and Regulations

(a) Re-arranged and re-numbered regulations

It was noted that the re-arranged and re-numbered ISAF Regulations based on the approval of proposals 1,2 and 3 of Submission 037-09 will be published in 2011 with all amendments approved by Council at the November meeting. The revised format includes reference to the current numbering for ease of use.

(b) Proposals to remedy defects in the committee appointments procedure

# 10. Olympic Commission Report

The Chairman confirmed that there were no issues for raised requiring specific input from the Constitution Committee.

## 11. Annual Report

The Chairman summarised the items that would be included in the verbal report to be given at the ISAF Council meeting of 11 November 2010 on the activities of the Constitution Committee since the meeting of Council in November 2009.

# 12. Any Other Business

- (a) Obstacles to timely progression to Full Membership Status
  - i) English version of Constitution document

The current requirement for the Constitution document of all applications to be in English was discussed at length. This has been an increasingly significant factor in delaying the progress of several applications for Full Membership Status and consequently contrary to facilitating the increased membership objectives of the Strategic Plan.

#### **Decision**

The Working Party of Tom Schubert, Scott Perry and Peter Hall shall review all applications and make recommendations to the Constitution Committee. Where appropriate the requirement for the Constitution documents to be in English may be waived subject to confirmation from a member of the Constitution Committee fluent in the language in question that the documents fulfil all requirements in order for a recommendation to be made by the Working Party to the Constitution Committee

ii) Recognition by the NOC

It was noted that the current procedure for full membership requiring the relevant NOC to recognise the sporting organisation before ISAF can consider an application is contrary to IOC practice of recognising sporting organisations which are recognised first by the International Federation.

## **Decision**
