NOTICE OF RACE

1 ORGANISING AUTHORITY

The Organising Authority (OA) will be the Singapore Sailing Federation.

2 VENUE

The venue will be at the Marina Barrage, Singapore.
8 Marina Gardens Drive Singapore 018951

3 EVENT GRADING

The regatta will be an ISAF Grade 5 event.

4 PROVISIONAL PROGRAMME

- 4.1
- (a) Registration will start on 25th June 2011 from 0900hrs to 1000hrs.
 - (b) Crew weighing, if applicable, See NOR 9(a) will be on 25th June 2011 from 0900hrs to 1000hrs.
 - (c) There will be no practice time allocated for this event. However, boats are available for chartering at the venue from 12th June 2011. Please enquire with OA (Tel: 64444555).
 - (d) First briefing and meeting with the umpires will be on 25th June 2011 at 1000hrs.
 - (e) Racing days are 25th and 26th June 2011.
 - (f) Time of the first race each day shall be from 1030hrs.

4.2 Unless prior exemption is given by the OA, attendance at the following is mandatory:

- (a) Initial briefing for all sailors.
- (b) Daily briefing for all sailors.
- (c) Prize giving ceremony.

5 SKIPPERS ELIGIBILITY

- (a) 8 skippers representing SSF affiliates will be invited. Only skippers invited by the OA will be eligible to enter this event. In the event any affiliate decline participation, or additional slots can be created, the OA shall use its discretion to allocate such vacant slots to other teams on wait list.
- (b) The registered skipper shall helm the boat at all times while racing, except in an emergency.
- (c) To remain eligible, a skipper shall confirm acceptance of invitation in writing, both fax and email are acceptable and are to be received by the date specified on the letter of invitation.
- (b) All competitors shall meet the eligibility requirements of ISAF regulation 19.2.

6 ENTRIES

- 6.1
- (a) The skipper shall be considered as having entered when all completion of registration, crew weighing and the payment of all fess and damage deposits. All payments shall be made in cash.

6.2 Entry Deadline & Fee

- (a) All entries shall be made on prescribed entry form to reach SingaporeSailing Federation located at 1500 East Coast Parkway, National Sailing Centre Singapore 468963 **no later**

than 1700 hrs on 12 June 2011 and accompanied by a non-refundable entry fee of S\$300 and initial damage deposit of \$500. Late entries may be accepted at the discretion of OA and upon payment of a late entry fee of \$350. All cheques to be made out to “SingaporeSailing Federation”.

6.3 Damage Deposit

- (a) The initial damage deposit of S\$500 is the maximum payable by the skipper as a result of any one incident.
- (b) In the event of a deduction from the damage deposit is decided by the OA it may require that the deposit be restored to its original amount before the skipper will be permitted to continue in the event.
- (c) Any remaining deposit after the event will be refunded within 10 days after the event.

6.3 Insurance

Each participating competitor shall be responsible to take out his/her own adequate third-party liability insurance.

7 RULES

- 7.1 The event will be governed by the rules as defined in the RRS, and including Appendix C.
- 7.2 Add to RRS 41: (e) help to recover from the water and return on board crew members provided the return on board is at the approximate location of the recovery.
- 7.3 National Umpires will be appointed, approved by the national authority, in accordance with RRS Appendix N.
- 7.4 All competitors are required to wear an approved Personal Flotation Device (PFD) at all times whilst afloat.
- 7.5 The rules for changes to the boat's settings and equipment will be detailed in the Sailing Instructions.

8 BOATS AND SAILS

- (a) The event will be sailed in Platu 25.
- (b) 4 boats will be provided.
- (c) The following sails will be provided for each boat:
Mainsail, Jib, Spinnaker.
- (d) Boats will be allocated by draw, either daily or for each round as decided by the Race Committee.

9 CREW (INCLUDING SKIPPER)

- (a) The number of crew (including the skipper) shall be 4 in the open category and 5 in the women category.
- (b) The maximum total crew weight, determined prior to racing shall be 350 kg (open category) and 340 kg (women category), when wearing at least shorts and shirts.
- (c) When a registered skipper is unable to continue in the event the Umpire may authorise an original crew member to substitute.
- (d) When a registered crew member is unable to continue in the event the Umpire may authorise a substitute, a temporary substitute or other adjustment.

10 EVENT FORMAT

- (a) The event will consist of the following stages:

Stage 1 - a single round robin

Stage 2 - Semi Final

Stage 3 - Final

- (c) The OA may change the format, terminate or eliminate any round, when conditions do not permit the completion of the intended format.

11 COURSE

- (a) The course will be windward/leeward with starboard roundings, finishing downwind.
- (b) The intended course area will be the waters in front of the Marina Barrage. Please refer to Appendix A for reference.

12 ADVERTISING

- (a) As per boats and equipment will be supplied by the Organising Authority. ISAF regulation 20.4 applies. Each boat will be required to display advertising as supplies by the OA.
- (b) Competitors may be permitted to display advertising ashore at the venue, but this is subject to individual regulation with the Organising Authority.
- (c) Boats shall not be permitted the right to protest for breaches of any rules regarding advertising (amends RRS 60.1)

13 PRIZES

- (a) There will be at the least, trophies to be awarded as prizes for the Top 3 positions..

14 MEDIA, IMAGES AND SOUND

- (a) The OA have the right to use any images and sound recorded during the event free of any charge.

15 COACH BOATS (Not Applicable)

Coach boats shall not be allowed.

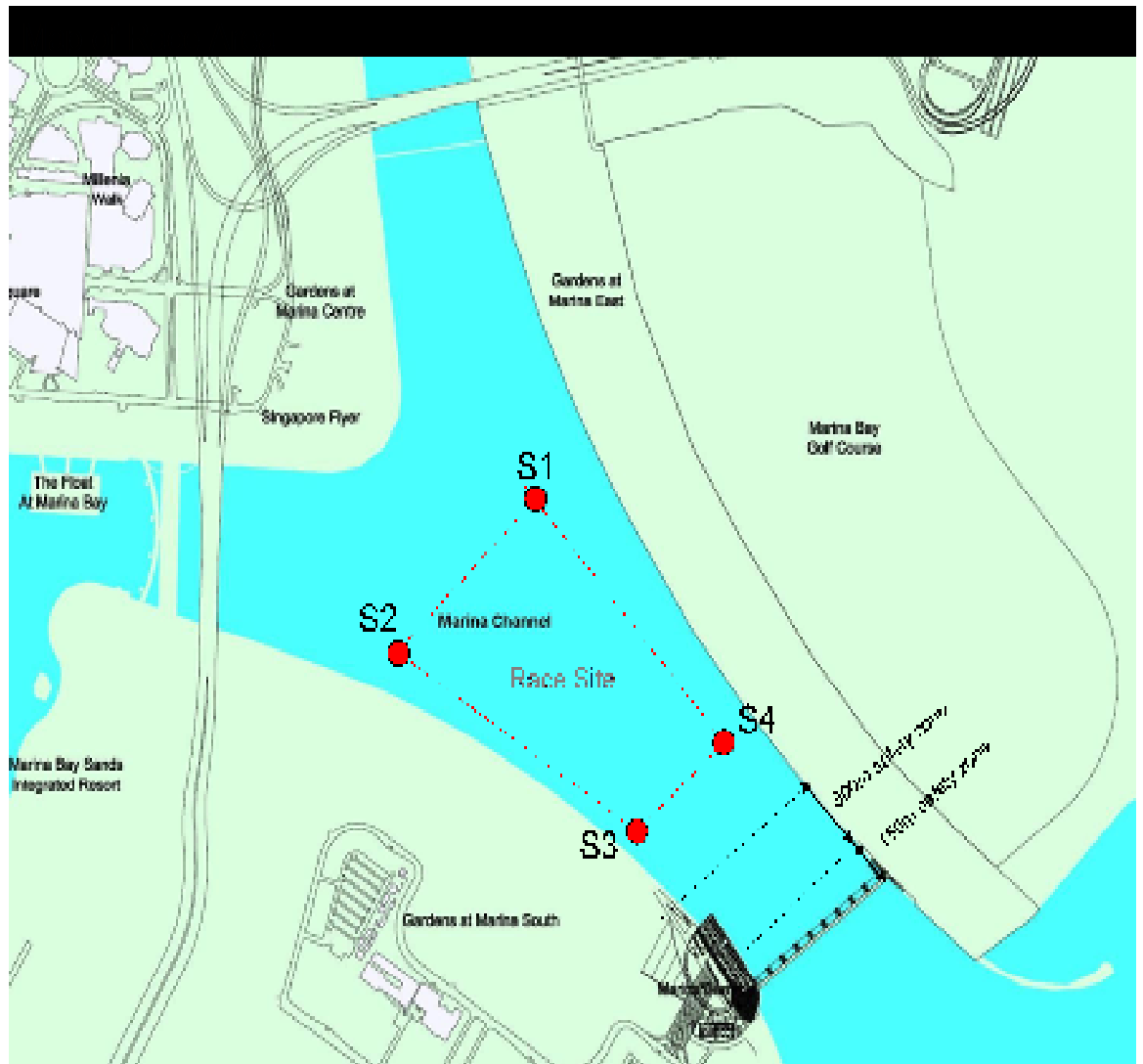
16 DISCLAIMER
