IFDS Development Committee Member Caterina Gouleliou-Tsantilis welcomed all participants and opened the meeting.

IFDS President Linda Merkle was introduced and a background about IFDS and how she became involved in sailing for people with disabilities was given.

Information about Blind Sailing was given and this included details about the varying degrees of visual acuity and how athletes with limited vision can take part in sailing. Henry Sleutel talked about the bleeping devices which are used to determine whether to round buoys to Port or Starboard.

A brief description about adaptations was given and how these are made to enable people with disabilities to sail independently.

The process which IFDS uses to assess the functional ability of athletes with disabilities was discussed.

When holding an event for people with disabilities, a number of items should be considered. These include;

- 1. Car parking facilities;
- 2. Height of the notice boards;
- 3. Access to the water (Is the surface suitable for wheelchairs);
- 4. Ramps to the pontoons.
