"The minimum total weight of the assembled hulls, Hull Appendages, and **Rig**, as defined in Sections D, E, & F of these Class Rules, shall be 155kg when in dry condition."

Amendment: Add new rule to read as follows:

"Tell tales are permitted; their number, placement, and materials are optional."

Amendment: Add new rule D.2.3 (c) to read as follows:

"Limited by compliance with class rule E.3, fairing the forward bottom end of the centreboard slot is permitted."
