Beautiful location, with significant onshore and offshore limitations.

(a) ASHORE:

GOOD: Ability to launch many boats at the same time; immediate access to measurement tent; good and friendly security; very comfortable integration with beach goers.

BAD: The beach-based boat park constantly exposed boats to sand damage; on some practise days the surf prevented launching.

(b) AFLOAT:

GOOD: Cascais has varied and challenging conditions. It is a very good sailing venue.

BAD: The number of racing areas and the clustering of the race areas undermined the racing conditions. Some of the race areas had very erratic conditions, and the race officers commented that they would have located the race areas differently.

Please state any recommendations for future World Championship events a) at the same venue

For single class World Championships, Cascais is a superb venue.

For multiclass/ISAF World Championships, it has limits.

- The Race Officers should be brought in to determine the number and location of race areas.
- Fleet sizes were too big in 2007; none of the classes completed their schedule; two classes had cancelled Medal Races; no re-scheduling was possible; reserve days were mandatory, and not available for making up races.

As a single class event, the Marina facilities are more than sufficient. For an all-classes event, the beach is hard (costly) on equipment and access to stored equipment was less than ideal.
