## 2. Annual Report

The Committee Chairman gave a general report on the activity of the new formed Classes Committee.

A survey was sent last year to all WS classes to know more about them and understand any particular concerns. As direct result of this survey a few submissions have been made by the WS Classes Committee.

Key discussions in 2017 were around Anti-Discrimination and Anti-Monopoly regulations as well as the work in a joint Working Party between Classes, Events, Equipment, Youth and Women's forum.

The classes pages in the WS website will be redesign to adequate the content to better fit the classes particular needs.

Some work will also be done on the Committee's Terms of Reference and discussions have been started with the Chairman's of the other Committees to see what issues are important and relevant to this Committee and to see how they can be dealt with. In order to achieve this, it is important to have a constant input flow from all classes without having to wait for the Annual Conference to take action on certain issues.

Corinne McKenzie gave a report on the Olympic Classes sub-committee meeting held at the WS Headquarters last February and a meeting held by Corinne in October in the new offices to discuss particular issues with new staff members.

It is the intention of the Olympic Classes Sub-committee and the Classes Committee to separate issues that are strictly relevant to their own committee.

This year many Olympic classes have been busy testing format for the Olympic Games and the Olympic Classes Sub-committee has also been discussing Continental Qualification and safety equipment and procedures.

Corinne also noted that last year there was a change in the Regulations meaning that the Olympic Classes Sub-committee cannot do recommendations directly to Council any more but through the Classes Committee. The situation is not ideal because of scheduling but especially because of possible conflict of interest and positions between the International Classes and the Olympic Classes particular agenda.

Markus Schwendtner proposed the creation of a functional grouping of all WS classes in order to be able to channel opinions and discussion more efficiently during the year. This functional grouping would be also reflected on the WS Website once its restructuration takes place.

## 3. Executive Office Report

- (a) Carlos de Beltran, Director of the Technical and Offshore Department gave an overview of the services offered by the Technical and Offshore Department and encouraged all classes to keep in touch with any technical issues they may have.
- (b) Jon Napier gave a report on the current situation on Anti-monopoly and Anti-trust. At the

moment, all the work has been focused into Olympic Classes, but the principles can be easily extrapolated into all WS Classes. The way WS deals with Equipment shall comply with mainly European law, since this is the stricter law but also with current competition law. Three areas are being considered, how do we select equipment for Olympic Events and how do we make sure it complies with anti-trust policies; then the review of Contracts with Olympic Classes; finally, when an event is chosen, making sure that there is a fair open trial where manufacturers can bring their equipment and the whole process is open and transparent,

## 5. Safety

- (a) Carlos de Beltran gave a report on general issues regarding safety. One of the main need is to develop an incident reporting system. This is planned to be done by an online system on the WS website so that classes can report any incident that happens in an event. A safety panel based within the Executive Office will then be able to take appropriate action depending mainly on the severity of the incident and the likelihood of re-occurrence.
- (b) Dina Kowalyshyn gave a verbal report on the work of the Sailor Safety Equipment Working Party. The work of the working party has been aimed not only at racing but to all kinds of sailing. The working party has looked not only into all different aspects of safety equipment, i.e. lifejackets but also its appropriate use, i.e. weather conditions. The working party welcomed any feedback in order to make sure all aspects of safety equipment are taken into account.

#### 6. Sustainability

Dan Reading presented the Sustainability Agenda 2030 to be launched on the 7<sup>th</sup> November. The agenda is formed mainly by 59 targets and one of the first objectives is to get feedback from all stakeholders around the world to enable the new formed Sustainability Commission to tackle short and long-term projects. Stakeholders can leave feedback via a survey on the

World Sailing Website.

The agenda will focus on the six key areas of sailing activities, from technical standards, events, venues and facilities, members, training and participation.
