1. MINUTES OF THE PREVIOUS MEETING

(a) Minutes

The Committee noted the minutes of the Events Committee meeting of 5 May 2006.

(b) Minutes – matters arising

There were no matters arising (not covered elsewhere on this agenda).

2. 2008 OLYMPIC REGATTA

(a) Submission 089-06

The Committee considered submission 089-06 from the Executive Committee about the weighting of the medal race scores.

EVENTS COMMITTEE (CONT.)

Recommendation to Council

The Events Committee has no recommendation to Council for submission 089-06 from the Executive Committee about the weighting of the medal race scores as it was withdrawn.

(b) Submission 064-06

The Committee considered submission 064-06 from the Chairman of the Events Committee about Format for Olympic Windsurfing. The Committee noted and agreed with the recommendation of the Windsurfing Committee.

Recommendation to Council

The Events Committee recommends to Council to approve with the following amendments:

*A new media friendly course for **the 2008** Olympic Windsurfing **Medal Race** is proposed.*

For a basic ~~trapezoid~~ and windward/leeward course a technical element should be added before the finishing line.

- a) The finishing line is as close to the beach/harbour as possible.*
- b) **2 or 3** extra buoys of a different colour makes a “slalom part” before the finishing line*
- c) The length of the “slalom part” is predicated on the strength of wind*
- d) Organized for easy and good media and spectators coverage*

Vote: Unanimous

(c) Submission 065-06

The Committee considered submission 065-06 from The International Finn Association and the Barbados Sailing Association about unallocated places at the 2008 Olympic Games. The Committee agreed that adding the Heavyweight dinghy in the single handed events which can use unallocated places at the 2008 Olympic Games would be beneficial in attracting more nations to the Games.

Recommendation to Council

The Events Committee recommends to Council to approve submission 065-06 from The International Finn Association and the Barbados Sailing Association about unallocated places at the 2008 Olympic Games.

Vote: Unanimous

EVENTS COMMITTEE (CONT.)

3. OLYMPIC CLASS EVENTS

(a) Submission 066-06

The Committee considered submission 066-06 from Koninklijk Nederlands Watersport Verbond about International Race Officers at Grade 1 Events. The Committee expressed concerns about cost and felt that made it mandatory for grade 1 events would broaden the requirement too much.

Recommendation to Council

The Events Committee recommends to Council to reject submission 066-06 from Koninklijk Nederlands Watersport Verbond about International Race Officers at Grade 1 Events.

Vote: 16 in favour (of rejecting), 0 against, 3 abstentions

(b) Submission 067-06

The Committee considered submission 067-06 from Koninklijk Nederlands Watersport Verbond about a medal race format for Olympic class events. The Committee agreed to accept as amended, but also taking on board the recommendations of the Format Working Party.

Recommendation to Council

The Events Committee recommends to Council to approve submission 067-06 from Koninklijk Nederlands Watersport Verbond about a medal race format for Olympic class events with the following amendment:

- 1. All Olympic multi class grade 1 events should run medal races.*
- 2. All World Championships of Olympic Classes should run medal races.*
- 3. All Continental Championships of Olympic Classes should run medal races.*
- 4. On the day of a medal race, those not qualified should have a race.*
- 5. The three letter score of a medal race should be equal to double points of the last group sailed in. (WP paper)*
- 6. A medal race (also at the Olympics) should be four laps with a target time for the total course of 25/30 minutes or three laps with a target time of 20/25 minutes. (WP paper)*

Vote: 17 in favour, 0 against, 2 abstentions

(c) Submission 068-06

The Committee considered submission 068-06 from Koninklijk Nederlands Watersport Verbond about a medal race format at Continental Championships for Olympic Classes.

Recommendation to Council

The Events Committee has no recommendation to Council as submission 068-06 from Koninklijk Nederlands Watersport Verbond about a medal race format at Continental Championships for Olympic Classes was withdrawn.

EVENTS COMMITTEE (CONT.)

(d) Submission 069-06

The Committee considered submission 069-06 from the Federacao Brasileira de Vela e Motor about the entries procedures at international events. The Committee felt that this would introduce unnecessary bureaucratic obstacles. It was also noted that current ISAF Rules already provide sufficient disciplinary rules.

Recommendation to Council

The Events Committee recommends to Council to reject submission 069-06 from the Federacao Brasileira de Vela e Motor about the entries procedures at international events.

Vote: 15 in favour (of rejecting), 4 abstentions

(e) Submission 070-06

The Committee considered submission 070-06 from the Real Federacion Española de Vela about classification of venues for Olympic Classes events. The committee felt that classification is not needed. Many classes and ISAF already have set criteria for selecting venues.

Recommendation to Council

The Events Committee recommends to Council to reject submission 070-06 from the Real Federacion Española de Vela about classification of venues for Olympic Classes events.

Vote: Unanimous in favour (of rejecting)

4. ISAF CALENDAR OF EVENTS

(a) Submission 071-06

The Committee considered submission 071-06 from Deutscher Segler-Verband about the scheduling of events. It was noted that regulations are already in place.

Recommendation to Council

The Events Committee has no recommendation to Council as submission 071-06 from Deutscher Segler-Verband about the scheduling of events was withdrawn.

(b) Submission 072-06

The Committee considered submission 072-06 from the Koninklijk Nederlands Watersport Verbond about the scheduling of events. It was noted there is a reference in the Strategic Plan notes that the Secretariat is to make a proposal on the calendar of events structure. The submission is to be regarded as support to the secretariat using the regulations and actively manage the calendar of events.

EVENTS COMMITTEE (CONT.)

Recommendation to Council

The Events Committee recommends to Council to approve submission 072-06 from the Koninklijk Nederlands Watersport Verbond about the scheduling of events.

Vote: 16 in favour, 0 against, 3 abstentions

5. ISAF WORLD CUP SERIES

- (a) The Committee received a proposal from a group including representatives of the multi-class grade 1 event organisers and the Olympic classes to amend submission 73-06.

- (b) Submission 073-06

The Committee considered submission 073-06 from the Fédération Française de Voile and US Sailing about an ISAF World Cup Series and agreed the proposed amendments.

Recommendation to Council

The Events Committee recommends to Council to approve with the following amendment. (See attachment 1)

Vote: 17 in favour, 0 against, 2 abstentions

- (c) Submission 074-06

The Committee considered submission 074-06 from the Koninklijk Nederlands Watersport Verbond about an ISAF World Cup Series.

Recommendation to Council

The Events Committee has no recommendation to Council as submission 074-06 from the Koninklijk Nederlands Watersport Verbond about an ISAF World Cup Series was withdrawn.

6. OLYMPIC EVENTS & EQUIPMENT

- (a) The Committee received a progress report by the Events Committee, Events & Equipment Selection Working Party. It was noted that the number of events will be reduced from 11 to 10. The Chairman of the Working Party reminded the Committee of the process of the selection of events and equipment for the next Olympic regatta:-
- In May 2007 the list of possible events will be established;
 - In November 2007 the events will be decided;
 - In November 2008 the equipment will be decided;
 - When considering the events the Committee should bear in mind:-
 - The ratio male/female/open events;
 - Consider 'mandatory open' events (mixed);

EVENTS COMMITTEE (CONT.)

- What events are appealing to the emerging nations;
- What events are 'duplications' in their appeal to the same 'style' of sailors;
- Consider the ratio 'out of a box equipment'/other equipment;
- Consider one person equipment for heavy and light for women;
- Media appeal.

The Chairman of the Working Party invited the Committee to make contributions to the discussion within the Working Party. The Committee expressed to be kept informed of the progress made by the Working Party.

(b) **Submission 075-06**

The Committee considered submission 075-06 from the RS:X Class about athlete supplied equipment at the 2008 Olympic Games. The Committee considered the benefits and disadvantages of supplied equipment. The Committee noted the recommendation by the Windsurfing Committee.

Recommendation to Council

The Events Committee recommends to Council to reject submission 075-06 from the RS:X Class about athlete supplied equipment at the 2008 Olympic Games.

Vote: 14 against, 1 in favour, 2 abstentions

(c) **Submission 076-06**

The Committee considered submission 076-06 from the Federacao Brasileira de Vela e Motor about Olympic equipment.

Recommendation to Council

The Events Committee recommends to Council to reject submission 076-06 from the Federacao Brasileira de Vela e Motor about Olympic equipment.

Vote: 18 in favour (of rejecting), 0 against, 1 abstention

(d) **Submission 077-06**

The Committee considered submission 077-06 from the Federacao Brasileira de Vela e Motor about Olympic equipment.

Recommendation to Council

The Events Committee recommends to Council to reject submission 077-06 from the Federacao Brasileira de Vela e Motor about Olympic equipment.

Vote: 17 in favour (of rejecting), 0 against, 2 abstentions

(e) **Submission 078-06**

The Committee considered submission 078-06 from the Federacao Brasileira de Vela e Motor about Olympic women's keelboat – match racing.

EVENTS COMMITTEE (CONT.)

Recommendation to Council

The Events Committee recommends to Council to defer submission 078-06 from the Federacao Brasileira de Vela e Motor about Olympic women's keelboat – match racing.

Vote: Unanimous in favour (of deferring)

(f) **Submission 079-06**

The Committee considered submission 079-06 from the Executive Committee about Olympic equipment selection. The Committee felt that removing this regulation will have some undesirable effect on the Regional Games. It was agreed that before acting on this submission the consequences of removal should be studied.

Recommendation to Council

The Events Committee recommends to Council to defer submission 079-06 from the Executive Committee about Olympic equipment selection.

Vote: 18 in favour (of deferring), 0 against, 1 abstention

7. REGULATION 18.2

ISAF approved (class) World Championships. The Committee received a report by Phil Jones about the minimum participation requirements for class World Championships. The following conclusions were made:-

- The quality of the data is poor;
- In its current form, collecting the data for the purpose of reviewing the World Championships, is very time consuming;
- In co-operation with the Equipment Committee the process of collecting and presenting the data should be improved.
- A Working Party should be formed to assist in the work.

8. 2007 ISAF WORLD CHAMPIONSHIPS – CASCAIS PORTUGAL

- (a) The Committee received a progress report and a detailed presentation from Miguel Magalhães, President of the Clube Naval de Cascais.

(b) **Submission 080-06**

The Committee considered submission 080-06 from the Danish Sailing Federation about the qualification system for the 2007 ISAF World Sailing Championships. The Committee agreed that outcome of the approved system has shown some undesirable features and supports the proposals discussed to improve the situation especially for countries not having sent more than one boat to the qualification events. See attachment 2.

EVENTS COMMITTEE (CONT.)

Recommendation to Council

The Events Committee recommends to Council to approve submission 080-06 from the Danish Sailing Federation about the qualification system for the 2007 ISAF World Sailing Championships with the following amendment:

Insert after 'up to a maximum of 4': places per class.

Delete the proposed amendments in item 1.1 (c).

Additional comment: Guidance was given to the Qualification Commission in the way the Commission places are allocated. It was recommended that those places are allocated as much as possible based on objective quality indicators such as results in World Championships or ISAF ranking positions.

Vote: 10 in favour, 0 against, 9 abstentions.

(c) 2011 ISAF World Championship

The Committee discussed and agreed the bid process and time table for the 2011 ISAF World Championships. Proposed dates for the bidding process as the proposed time line was against the regulations:

Timetable for 2011 ISAF World Championships

- The registration of bids starts from now until June 2007.
- In June/July 2007 the Worlds can be studied/observed by the potential bidders.
- Before that time ISAF can assist the bidders in 'transfer of knowledge'.
- Final bids to be in by September 2007.
- Bid evaluation in October 2007.
- Decision by the ISAF Executive in November 2007.
- Note: changes in the regulations will be necessary.

9. ISAF WORLD SAILING GAMES

(a) The Committee received a report by the Technical Delegate.

The Chairman congratulated the organisers of the 2006 World Sailing Games with the success of the inclusion of the two-boat-per-team team racing event which provided a great spectacle for the spectators on the final day.

(b) Submission 081-06

The Committee considered submission 081-06 from the International Hobie Class Association about the ISAF World Sailing Games equipment.

EVENTS COMMITTEE (CONT.)

Recommendation to Council

The Events Committee recommends to Council to defer submission 081-06 from the International Hobie Class Association about the ISAF World Sailing Games equipment.

Vote: Unanimous in favour of deferring

10. ISAF YOUTH SAILING WORLD CHAMPIONSHIP SUB-COMMITTEE

(a) Progress Report

The Committee received a progress report by the Chairman of the Sub-Committee. The following matters were presented to the Committee to deal with:-

- The ISAF Youth Sailing World Championship 2008

Based on a proposal from the 2008 Event Organising Committee and the host MNA, it is recommended that the SL16 is chosen as the equipment for the multihull discipline for the 2008 ISAF Youth Sailing World Championship. Note: The equipment for the other disciplines has already been decided in May 2006.

Vote: 14 in favour, 2 against, 1 abstention

- The ISAF Youth Sailing World Championship 2009

Based on a proposal from the 2009 Event Organising Committee and the host MNA, the equipment recommended for the 2009 Championship is:-

One person dinghy boys – Laser

One person dinghy girls – Laser Radial

Two person dinghy boys – 420

Two person dinghy girls – 420

Multihull – Hobie 16 with spinnaker

Windsurfer boys and girls – RS:X with 8.5m² sail & 60cm fin

Vote: Unanimous

- The ISAF Youth Sailing World Championship 2010

The Sub-Committee recommends for the 2010 ISAF Youth Sailing Championship that the bid from Turkey to host the Championship is accepted, subject to a successful site visit and satisfactory contractual arrangements. A final confirmation by ISAF of the selection of the venue in Turkey shall take place after the site visit by ISAF.

Vote: Unanimous

(b) Submission 082-06

The Committee considered submission 082-06 from Yachting Australia about the ISAF Youth Sailing World Championships.

EVENTS COMMITTEE (CONT.)

Recommendation to Council

The Events Committee recommends to Council to reject submission 082-06 from Yachting Australia about the ISAF Youth Sailing World Championships.

Vote: 15 in favour (of rejecting), 2 against, 1 abstention

(c) **Submission 083-06**

The Committee considered submission 083-06 from the Chairman of the Events Committee about the ISAF Youth World Championships regulation 17.4.5 (dates). The proposal would allow for more flexibility for the selection of dates, especially for nations close to the Equator.

Recommendation to Council

The Events Committee recommends to Council to approve submission 083-06 from the Chairman of the Events Committee about the ISAF Youth World Championships regulation 17.4.5 (dates).

Vote: Unanimous

(d) **Submission 084-06**

The Committee considered submission 084-06 from the Chairman of the Events Committee about the ISAF Youth World Championship regulation 17.4.9 (equipment). The proposal will bring the regulation in line with current practice.

Recommendation to Council

The Events Committee recommends to Council to approve submission 084-06 from the Chairman of the Events Committee about the ISAF Youth World Championship regulation 17.4.9 (equipment).

Vote: Unanimous

(e) **Submission 085-06**

The Committee considered submission 085-06 from the Real Federacion Española de Vela and Federación Argentina de Yachting about the ISAF Youth Sailing World Championship Regulation 17.4.10 (events). The Committee agreed that the issue should be studied and referred this back to the Championship Sub-Committee.

Recommendation to Council

The Events Committee recommends to Council to defer submission 085-06 from the Real Federacion Española de Vela and Federación Argentina de Yachting about the ISAF Youth Sailing World Championship Regulation 17.4.10 (events).

Vote: 9 in favour (of deferring), 8 against, 2 abstentions

EVENTS COMMITTEE (CONT.)

11. ISAF TEAM RACING WORLD CHAMPIONSHIP SUB-COMMITTEE

(a) Progress Report

The Committee received a progress report by the Chairman of the Sub-Committee. The venue of the 2007 ISAF Team Racing World was reconfirmed to be West Kirby, United Kingdom 20-25 August.

2009 ISAF Team Racing World Championship

The Sub-Committee recommends for the 2009 Team Racing World Championship the bid from Australia to host the Championship is accepted, subject to a successful site visit and satisfactory contractual arrangements.

Vote: 18 in favour, 0 against, 1 abstention

(b) Submission 086-06

The Committee considered submission 086-06 from the Chairman of the Events Committee about the ISAF Team Racing World Championship.

Recommendation to Council

The Events Committee recommends to Council to accept submission 086-06 from the Chairman of the Events Committee about the ISAF Team Racing World Championship.

Vote: 15 in favour, 1 against, 4 abstentions

12. ISAF RANKINGS SUB-COMMITTEE

- (a) The Committee received a progress report by the Chairman of the Sub-Committee. As a general comment, the Chairman reported the recommendation of the Sub-Committee for ISAF to look into the possibility of removing regulation 24 “*ISAF World rankings – grading criteria for graded events*” to a new form of rule (bye-law?), so that operational changes to the management and calculation of the ranking list can be achieved more quickly than through a submission to change the regulation. Potential changes to such a “bye-law” should be approved by the Executive Committee.

(b) Submission 087-06

The Committee considered submission 87-06 from Real Federacion Española de Vela about criteria for ranked events.

Recommendation to Council

The Events Committee recommends to Council to reject submission 87-06 from Real Federacion Española de Vela about criteria for ranked events.

Vote: 14 in favour (of rejecting), 1 against, 2 abstentions

EVENTS COMMITTEE (CONT.)

(c) Submission 088-06

The Committee considered submission 088-06 from Deutscher Segler Verband about a new rankings Sub-Committee. The Committee felt a Sub-Committee is unnecessary, the event organisers are encouraged to get together as much as needed without being a format committee within ISAF.

Recommendation to Council

The Events Committee recommends to Council to reject submission 088-06 from Deutscher Segler Verband about a new rankings Sub-Committee.

Vote: 11 in favour (of rejecting), 2 against, 6 abstentions

13. COMPETITION FORMAT FUTURE OLYMPIC REGATTAS

The Committee received a report from the Working Party. The Committee did not agree with the recommendation of the target time for keelboats to be 40 minutes. It was agreed this should be 30 minutes. The importance of agreeing a standard format for grade 1 events was highlighted and the principles of the standard format were agreed (see attachment 3). The other recommendations (not in attachment 3) were:

1. Develop a promotion package for medal events:
 - Press release introducing all the grade one events, ISAF events and test events
 - Produce a “demo-reel” of the medal race format
 - Live footage available for the media from all the medal races

2. Medal format guideline

Scoring system and format for medal race at ISAF Worlds, Olympic Test Event and ISAF Grade 1 Events.

- Double Points
- No Discard
- 3 Letter Score = 22 pts
- Must start & finish the last Race, otherwise penalty of 10th Place Overall
- Scoring to be visualized on Sails
- Penalties by Judge = 2 tacks + 2 gybes; two turn penalty (44.2)
- Individual Penalty = 1 tack + 1 gybe; one turn penalty (31.2)

Dinghy / Multihull	30 Min	Windward/Leeward	3
49er/Windsurfing	25 min	Windward/Leeward + slalom finish for windsurfing	3

EVENTS COMMITTEE (CONT.)

3. The working party should identify new ideas, re. new formats, elimination series, new courses, slalom etc. The package to be presented at the mid-year meeting in 2007 and a plan for test events for 2008/2009 to be developed.

14. ISAF STRATEGIC PLAN

(a) Update

The Committee received a verbal report from the Vice- President David Irish on the implementation of the ISAF Strategic Plan.

The Committee noted the briefing document on the ISAF Events Strategy to the ISAF Events Committee. Working Party Chairman Chris Atkins explained the timeline set for the Events Strategy: A draft to be presented for the 2007 mid year meeting and a final paper to be approved in November 2007. The Committee noted the existence of a previous approved events strategy paper and agreed that this would be a good starting point for the new paper. The Working party to produce the draft is: Chris Atkins(Chair), Cory Sertl, Jeff Martin, Olivier Bovyn and Takao Otani.

15. ANNUAL REPORT

To note the Chairman's report to the ISAF Council meeting of 10 November 2006 on the activities of the Events Committee for the period 1 January 2006 to date.

16. ANY OTHER BUSINESS

- Ahmet Mostar (TUR) clarified that, contrary to an earlier comment by the Chairman, Turkey has, at this stage, not indicated an interest in hosting the 2011 ISAF World Championships.

There being no further business the meeting was closed.

2007 & 2008 ISAF World Cup Events

A submission from Fédération Française de Voile and US Sailing

Proposal: (With amendments in BOLD)

1. That following events will be granted the label "ISAF World Cup" for 2007 & 2008 in order to recognize and protect the actual circuit:

Sail Melbourne

Miami OCR

Princess Sofia Palma

Semaine Olympique Française Hyeres

Holland Regatta

Kiel Week

ISAF World Championships 2007 – Class World Championships 2008

2. By being granted "ISAF World Cup" label, Organizing Authorities of these events agree to follow ISAF guidelines for improvement of homogeneity throughout the circuit.

3. For future years (2009 +) the ISAF to consider to expand and modify the ISAF World Cup so that there will be a "Grand Final Event" regatta for a limited number of entries (current target 25/class). The ISAF World Cup will be awarded at this regatta based on the results of the final regatta.

Current Position:

No current position.

Reason:

1. Those events are essential for all countries to prepare the teams for the Olympic Games:

Possible access for all countries, including emerging nations

Opportunity for countries to have the full team in one location

Opportunity for young sailors to meet the most experienced ones

The full community of Olympic sailors and Olympic classes may benefit of the media coverage and communication organized through those events.

2. Those events have been built through years of history, in order to offer good racing based on Olympic format, and facilities to full Olympic National teams. Event Organizers work permanently with team-leaders, competitors, MNA and Olympic Class representatives to achieve this goal and to bring the necessary improvements.

EVENTS COMMITTEE (CONT.)

The label « **ISAF** World Cup » should go in priority to the events making the circuit actually used by all nations for preparation and selection of their representatives to the Olympic Games.

3. All these events are organized on a similar way:

Use of Olympic Format (fleet split into groups – Umpired Medal Race – R42 on the water judging. Compliance with ISAF Race Officials requirements. Media coverage, Press office, Efficient Website)

4. A Final Event, with a limited number of entrants, will allow the sailing world to focus on the best and allow the media to get in depth access to the top athletes in a more easily managed venue where sponsor and media considerations will be catered to to ensure that our sport is well showcased. This venue can be placed in strategic areas in various years for the benefit of the Sport of Sailing.

Additional agreed points but not included in submission to Council.

Scoring 2007 & 2008:

Best results from 4 of the 6 previously listed events (maximum 3 from any 1 continent) plus the Class World results will be used to determine the World Cup placing.

Awarding of the World Cup will most likely be at the final event of the series or as agreed by ISAF after consultation with the sponsors, the media, the event organizers and the classes. This decision will be made by March 1, of the year of the World Cup.

Scoring beyond 2007 & 2008:

Best results from 4 of the 6 events (maximum 3 from any 1 continent) plus the Class World results will be used to determine who enters the World Cup Final Event.

The Final Event will be a stand alone scored regatta and the World Cup will be awarded based on this final regatta (no carry forward of results).

THE QUALIFICATION SYSTEM FOR THE 2007 ISAF WORLD SAILING CHAMPIONSHIPS

Proposal:

Document/article dated 17 July 2006 – “The qualification system for the 2007 ISAF World Sailing Championships – proposed changes:

1. General conditions

1.1 Entry places at the 2007 ISAF World Sailing Championships (the Championships) will be allocated to MNAs in 3 ways:

(a) Priority places - All MNAs are entitled to 1 entry place in each class, provided that the MNA applies for its entry place before 1 January 2007, and guarantees that it will use the entry place will be used

(b) Additional places **up to a max. of 6 4 in each class**- these will be allocated based on MNA

competitors' finishing positions at the 2005 and/or 2006 world championships.

(c) Commission places - Entry places not allocated under points 1.1(a) and 1.1(b) may be allocated by an ISAF Qualification Commission. **in the following priority:**

- ~~**A number two entry place in a class, if requested, for MNA's having only been allocated 1 entry place in the class according item 1.1(a) and 1.1(b) and 3**~~
- ~~**The rest of the places up to the maximum per event to be allocated to MNA's which according to item 2 could receive more than 6 additional places and if requested**~~
