## 1. MINUTES OF THE PREVIOUS MEETING

## (a) Minutes

#### 2. NEIL PRYDE RS:X

# (a) Update Report

The Committee received an update report from Rich Jeffries about the class and the class activities. The support of Neil Pryde was very much appreciated by ISAF and the sailors. At events some problems occurred with the new equipment but this was always quickly resolved because of the excellent back up provided by the team of Neil Pryde. Small adjustments to the equipment such as the mast extension have been made.

Several Committee members expressed great concern over the roll out and introduction of the Neil Pryde RS:X. There is evidence that the distribution may not have been fair and equal for all countries. Ailsa Angus informed the meeting that the roll out probably has not been perfect but that the distribution problems were now a thing of the past and that there are enough boards available to satisfy demand. If anyone experiences problems, they should not hesitate to contact either Neil Pryde and or ISAF.

## (b) Class Rules

The Committee received a copy and noted the current Class Rules. It was agreed that when further changes are introduced, the Committee will be informed of those changes.

#### 3. ISAF ADVERTISING CODE

## Submission 008-05 and submission 009-05

The Committee considered submission 008-05 from the International Formula Windsurfing Class Association about the change of Class Rule C4.1 and submission 009-05 from the International Funboard Association regarding the change of Class Rule C4.1.

## Recommendation to Council

It was noted that the submission could not be approved as it did not comply with the ISAF Regulations.

However it was agreed in the Committee that the current Advertising Code was not practical and that the advertising code should be amended for windsurfing. There are two issues: A clear definition of the maximum size of the events advertising, for which a maximum of 1m² is proposed. Secondly the place in the sail should be better defined to avoid obstructing the clear view for the sailor. It was agreed that the classes should address the issue and come forward with a joint proposal to change the regulation, to be made as a submission to ISAF through the chairman of the Windsurfing Committee.

# 4. APPLICATION FOR DESIGNATION AS A RECOGNIZED AND INTERNATIONAL CLASSES

## (a) <u>Submission 030-05</u>

The Committee considered submission 030-05 from the RS:X Class about granting a recognized status to the RS:X Class.

## Recommendation to Council

The Windsurfing Committee recommends to Council accepting submission 030-05 from the RS:X Class about granting a recognized status to the RS:X Class. It was noted that the class also complies with the requirements of number of continent and nations to be an International Class.

# (b) <u>Submission 031-05</u>

The Committee considered submission 031-05 from the Techno 293 Class about granting an International status to the Techno 293 Class. The Committee noted that the application is currently for a one design board with a box rule sail and an 'approved sail makers' list. Some Committee members urged the class to adopt a single design sail, as soon as possible and keep the cost down.

#### Recommendation to Council

The Windsurfing Committee recommends to Council accepting submission 031-05 from the Techno 293 about granting an International status to the Techno 293. The class believes the distribution requirements are met. It was noted that all windsurfing classes supported this submission as this class is important for the youth development of Windsurfing. The committee was also reminded that this class application was fully supported by the committee in November 2004 but that the application failed to be accepted because of technical issues which no longer existed.

## 5. STANDARD MEASUREMENT FOR WINDSURF SAILS

The Committee considered submission 045-05 from Federation Française de Voile about establishing and publishing a standard method for Area Measurement of Windsurf Sails.

## Recommendation to Council

The Windsurfing Committee recommends to Council to support submission 045-05 from Federation Française de Voile in principle about establishing and publishing a standard method for Area Measurement of Windsurf Sails. However it was noted that an ISAF standard already exists in the ISAF Guide to Measurement and calculation of sail area but this may not be very well known.
