The Race Officials Committee wish to strongly recommend that Council defer the above submissions relating to RRS 42, and appoint a Working Party to review RRS 42 and its application and interpretation in light of these submissions

Submission 090A-02 P

The Race Officials Committee recommends to Council that the submission be deferred.

The Committee agrees with the principles of control, but is concerned that this submission tackles two problems which need to be addressed separately. RRS 42 is a judging issue, whereas weight jackets, equipment adherence and corrector weights all fall under the jurisdiction of measurement. Therefore, the policy regarding these issues needs to be developed in conjunction with the International Measurers' Sub-Committee.

In addition, the Committee recommends that when forming the expert groups, similar consideration should be given to International Umpires, who are also required to implement RRS 42.
