Regulation 20

A submission from the Executive Committee

Purpose or Objective

In case of boats where the headsail overlaps the mainsail and/or where the spinnaker pole is stowed on the boom, to allow the Organizing Authority to require, in accordance with Regulation 20.4.1 and Table 1, the boats to display the Advertising on the backward part of the boom instead of the forward part of it.

Proposal

To amend Table 1 as follow:

- (1) In this table, the word 'boat' does not include windsurfers, kiteboards or radio-controlled boats.
- (2) If the boat has no **backstay**, the notice of race may require that the flag is attached to a **shroud**.

When a boat has a bow or forward transom, Advertising shall be allowed on this space in addition to the **hull** area stated in the table above.

Current Position

As above without change to size in Boom.

Reasons

The Dragon Class (and other classes) has the headsail overlapping the mainsail and the spinnaker pole stowed on the boom (in the forward part of it). It is therefore apparent that the Advertising that the Organizing Authority may require boats to display on the boom in accordance with Regulation 20.4.1 and Table 1 has a much less visibility in respect of those classes that do not have headsail overlapping the mainsail and/or the spinnaker pole stowed on the boom.

By allowing in such case the use of the backward part of the boom instead of the forward part of it the "problem" is solved without increasing the amount of space available to the Organizing Authority.
