1. Welcome & Introductions

The Chairman opened the meeting and welcomed everyone to the Events Committee meeting in St Petersburg.

The Chairman introduced the agenda and highlighted the key purposes for this meeting.

The Chairman gave a report on the ISAF Events Strategy Implementation.

2. Minutes of the Previous Meeting

(a) Minutes

The Events Committee noted the minutes of the Events Committee meeting of 10 November 2010. The minutes can be downloaded at www.sailing.org/meetings.

3. Conflicts of Interest

The current Statements of Interest were noted by the Committee. The following three Committee members Statement of Interest had altered from the November meeting in 2010: Chris Atkins, Chairman, Henri van der Aat and Oleg Ilyin.

The Chairman proposed to the Events Committee that we should make the same decision on voting on the provisional slate as in November 2010. This was agreed by the Events Committee.

Corinne Rolland-McKenzie advised the committee that she would not be taking part in the selection of Events and Equipment submissions.

4. Executive Committee Update

(a) The Committee noted the minutes of the Executive Meeting held in February in particular the following:

Item 9(b): The appointment of the YOG Working Party.

Item 13(b): The voting procedure for Olympic Events.

Item 15(f): Multi-hull commission comments on SL16.

Item 15(g): Creation of Information Technology and Tracking Commission.

Item 20(a): ISAF Sailing World Cup 2013 calendar decision.

Item 20(a): Match Racing Format change. Should come in for 2012.

Item 20(c): Selection of venue for the 2014 ISAF Sailing World Championships.

The Chairman informed the Committee that the Executive had denied a request from the Tornado Class for use of the title "Speedsailing World Cup".

5. Progress reports on current Olympic Pinnacle events

The Committee received progress reports on the following events:

(a) 2011 ISAF Sailing World Championships.

The Events Committee received a verbal report from the ISAF Events Manager Event.

It was reported that the Test Event, the Perth International Regatta (PIR) 16 - 23 November 2010, had been a great success and that a great deal had been learnt from the event; there were 230 entries from 40 nations. ISAF appointed the PRO (Charley Cook, USA), Jury Chair (Bernard Bonneau, FRA) and the Measurement Chair (Dick Batt, GBR) for the PIR along with the Technical Delegate (Alastair Fox, GBR) to work with the Perth 2011 teams. All of the recommendations from ISAF following the evaluation of the PIR had been taken on by the Perth 2011 event organisers as they prepare for the Perth 2011 ISAF Sailing World Championships.

The Events Manager also reported that both Swiss Timing and Sunset and Vine had been at the PIR and that the various parties were working closely to ensure a successful event.

The Chairman of the Qualification Commission reported on the entry process for the Perth 2011 ISAF Sailing World Championships. 661 entries from over 70 nations were

received by the first entry deadline. It was reported that the process was working well and the Committee noted that the final entry deadline was 30 June 2011.

(b) 2014 ISAF Sailing World Championships

The Events Committee received a report from the Events Committee representative of the 2014 ISAF Sailing World Championships Evaluation Commissions. The bid process and evaluation criteria were explained and it was noted that all of the cities had developed very strong bids. Bid presentations were made by Aarhus (DEN), Busan (KOR), Gdynia (POL), Kingston (CAN), Qingdao (CHN) and Santander (ESP).

The ISAF Events Manager confirmed that the Executive Committee confirmed Santander as the host city for the 2014 ISAF Sailing World Championships during their February 2011 meeting in Iceland. The Events Manager reported that a successful site visit had been carried out in April 2011 and that the venue and course areas were well suited to hosting the Championships and that the Organising Committee was well supported by the local, regional and national governments as well as by the Real Federacion Espanola de Vela.

The Events Committee approved the appointment of a Steering Group for the 2014 ISAF Sailing World Championships made up of:

(c) Sailing World Cup 2011 & 2012

The Events Committee received an update from the ISAF Events Manager. It was reported that attendance was very high when compared to previous years and that in many events the quotas were now being reached. The Events Committee also recognised the continued hard work and commitment of all of the Sailing World Cup event organisers. It was reported that work on the standard documents was continuing and that all of the events had appointed ISAF approved officials as the event PRO, Jury Chair, Chief Umpire and Measurement Chair. However it was noted that there were still inconsistencies in documentation between SWC events. It was agreed that reports evaluating the individual Sailing World Cup events should be circulated widely to help develop consistency and the quality of the events.

i) New "Steering Group"

The Events Committee noted that Tomasz Chamera had been invited to join Alberto Predieri, ISAF Vice-President and Alastair Fox, ISAF Events Manager on the Steering Group for the ISAF Sailing World Cup.

ii) Consideration of change to Match Racing Format

The Events Committee received an update from the ISAF Events Manager on the proposal to change the format of the round robin stage from 3 groups of 8 to 2 groups of 12. The Events Committee recommended that this was discussed further by the Steering Group as there was concern expressed over the additional numbers of races in the early rounds that this format change could create.

(d) Olympic Test Event 2011; Update on Documents. Working Group and Discretionary Penalties

The Committee received an update from the ISAF Events Manager. It was noted that the Documents Working Party was made up of:

The Events Manager reported that the Discretionary Penalty system needed to be integrated into the Olympic Test Event Sailing Instructions but that the process was well under way. It was noted by the Events Committee that the Test Event would provide a good opportunity for feedback and that the Discretionary Penalty system information should be made available on the event website.

The Events Manager requested that a change to Addendum Q should also be tested at the Olympic Test Event. The changes would help the media and spectators follow the medal races by making the Rule 42 penalty system the same as the system for other penalties during the medal races. The Events Committee approved the changes for testing.

The Events Committee noted that the entry deadline for the Olympic Test Event was 31 May 2011 and that all of the main event partner (ISAF, LOCOG, Swiss Timing, OBS, etc) would be at the event.

(e) 2012 Olympic Sailing Competition

The Committee received an update from the ISAF Events Manager. It was noted that tickets for the Sailing events had been included in the first LOCOG ticket ballot. The Nothe medal race course spectator area has the capacity for approximately 4,500 spectators and tickets were for sale at £35 for a normal day and £50 for a medal race day with reduced prices for children.

The ISAF Events Manager emphasised the importance of working with OBS and Swiss Timing to try and introduce a Commentator Information System and website tracking system for the Olympic Sailing Competition but it was noted that the final decision was not for ISAF to make.

The Committee discussed the Field of Play Course Strategy. It was agreed that:

fleets should race on the best available course area for sailing and spectators, rather than always on the same course area;

to maximise the racing close to spectators, and to give as many fleets as possible the experience of racing on the Nothe medal race course prior to the medal race, the use of the Nothe medal race course should be encouraged for some series races of as many fleets as practicable, providing fleet sizes permit.

The ISAF Technical Delegates and the ISAF PRO, in consultation with LOCOG, will decide on course allocations at the Olympic Sailing Competition and the Test Event for each fleet. They should balance increasing the number of laps with possible adjustment of target time for those races. Experimentation at the Test Event was strongly encouraged so that any Olympic decisions could be based on Test Event experience.

(f) 2016 Olympic Sailing Competition

The Committee received an update from the ISAF Events Manager. It was noted that the timing of the Test Events should take into consideration the overall Olympic sailing calendar. It was also noted that ISAF had a unique opportunity to show the sport to the world during the Olympic Sailing Competition and that the racing formats should be evaluated and approved as early as possible to help maximise this opportunity.

(g) Sports Presentation

- i) The ISAF Head of Marketing, Events and Training presented an update on marketing and media progress for the 2012 Olympics, Perth 2011, Sailing World Cup and Youth Worlds and an update on key general marketing activity.
- ii) It was requested by the Committee that future presentations on Sports Presentation should not just be verbal, and should include examples of sports presentation that ISAF has delivered at its events. The Committee also requested greater priority and urgency is given to the challenge of securing sponsorship.

6. Olympic Events & Equipment decisions

- (a) The Committee considered the following submissions regarding the voting procedure for events and equipment for the 2016 Olympic Sailing Competition:

The Chairman informed the Committee that the Chairman of Constitution Committee had advised that submission M36-11 was invalid as it did not propose 10 Events. During the debate the Chairman of Constitution Committee advised the Committee that submissions M23-11 and M37-11 were invalid as they proposed new Equipment for an Event.

The Chairman of the Equipment Committee informed the Event Committee on the Equipment Committee's "traffic light" assessment of these submissions against the criteria in regulation 23.1.2 and the workload in Equipment evaluation required.

It was agreed the voting would not be secret and that the Events Committee would vote on the Option numbers proposed in the CM paper EC_6(b), the Events Submission Summary.

- It was also noted that holding the first Asian SWC Event in 2012 just two to three months after the Olympics might be too soon, and that it might be better to delay the introduction of the first Asian event until 2013.

- It was noted that the ISAF Secretariat would finalise the bid guideline and services.

- i) The Events Committee received a report from the 2013 SWC Working Party that outlined the discussions surrounding the Grand Final.
- ii) The Events Committee recommended to Council that the Grand Final should not be included in the ISAF Sailing World Cup 2013 implementation plan

The Events Committee received a brief verbal report from the Chairman of the Olympic Commission and it was noted that a full report would be made in November 2011.

- (b) Classes' Format Trialling

- (c) Feedback from Events Organisers and LOCOG

- (d) To agree the establishment of a Format Working Party, and its timescales for reporting back.

The Events Committee established the Working Party and asked for a first report in November 2011.

10. ISAF Youth World Championships

- (a) The Events Committee received a progress report from the Chairman of the ISAF Youth Sailing World Championship Sub-committee. The Chairman advised the Events Committee that the ISAF Competitions Manager and the ISAF Head of Marketing, Events and Training had been to Portugal for a Site Visit for the 2014 event.

The Chairman of the ISAF Youth Sailing Worlds Sub-committee informed the Events Committee that she has been to Ireland to have a look at the venue for the 2012 Championship. It was noted that the planning was going well.

- (b) The Chairman of the ISAF Youth Sailing World Championships Sub-committee presented the initial 8 recommendations of the Sub-committee's Strategy WP. She invited Events Committee members to study the recommendations in the report, and to send her comments on them. The intention was to come forward with specific recommendations, submissions, and implementation plans in November 2011.

11. Youth Olympic Games

The Events Committee received a progress report from the ISAF Events Manager. The Events Committee were informed that Jerome Pels, Secretary General and Alastair Fox, ISAF Events Manager has been on a Site Visit to Nanjing in China for the 2014 ISAF Youth Olympic Games. It was noted that the sailing events would take place at Jinniu Lake where a purpose built venue was being developed. It was reported that wind strength in August was likely to be light; the average wind speed is expected to be 6-7 knots. It was noted that the Nanjing Youth Olympic Games Organising Committee and the Chinese Yachting Association would work closely with ISAF to ensure a successful event in 2014.

- (a) Youth Olympic Games Working Party.

The Events Committee noted the establishment of the Executive Committee 2014 Youth Olympic Games Working Party. The committee received a verbal report from the Chairman of the Working Party outlining the work carried out to date.
