In addition, the Committee recommends to the Board the appointment, tenure and remuneration of the external auditor and also has a duty to review compliance with various financial, statutory and regulatory requirements. The Board may request the Committee to supervise any special investigations relevant to the Committee's role and responsibilities or to examine any other matters referred to it by the Board.

In summary our role is one of a watchdog to oversee financial reporting and regulatory compliance. It is not the role of the Committee to advise on the financial management of World Sailing or to be involved in the management of the organisation's finances.

Due to the nature of the Committee's work, we work closely for, and report to, the Board. It would be inappropriate for the Committee to undertake investigations or other inquiries not commissioned by the Board.

The Committee recommends rejection of this submission and instead supports the Board's proposal to put forward the following changes to the Committee:

- a) The Audit Committee shall consist of three members, who should have expertise in financial management and reporting and risk management.
- b) One member shall be a Board member.
- c) Two members, including the Chair shall be independent members (i.e. not a Board member nor a member of staff).
- d) All three members shall be appointed by Council on the recommendation of the Board.
- e) The Committee shall continue to report to the Board, and also to Council and each Annual General Meeting.

OCSC Agenda Item 4: World Sailing Event Strategy: 2021 - 2028

The OCSC recommends that the Calendar Working Party is as flexible as possible for Class events from 2021-24 given the postponement of the Tokyo 2020 Olympic Games to 2021 and The Hague Sailing World Championships to 2023.

Following the report made on the WS Ranking system, the OCSC recommends that until the WS Ranking system is developed and functioning to satisfaction, it should not be used for any event selection.

The OCSC recommends that along with the World ranking system, Sailors ID be developed to a level where it can be used to promote the sailors.

OCSC Agenda Item 6: Paris 2024 Olympic Games and OCSC 2019 meeting minutes (6.2) reminder:

The OCSC recommends that the: "New formats for the Olympic Games are tested well ahead of the Olympic Games at events such as Youth events or other events not impacting Olympic sailors' campaigns."

The OCSC recommends that 2024 Olympic qualifications are tailored to each event taking into account the quota and the development level of the class used in the event. For events considered as "universal" with larger quota "Regions" should be considered rather than "Continents". Events with small quota could not have any Continental Qualification, or grouping of Continents should be considered. For events using new classes, the Olympic qualifications should be staged as late as possible in the quadrennial to allow sailors to get to the right level and equipment to be readily accessible by all teams around the world.

OCSC Agenda Item 7: The Hague 2023 Sailing World Championships

The OSCS requests that the World Sailing Executive Office and The Hague Organising Committee review the quotas for the Kiteboarding, One Person Dinghy and Skiff events.

OCSC Agenda Item 9: Race Officials

The OCSC recommends that race officials appointments in time of travel restriction be more flexible in term of judges geographic origin, and use available technology to enable remote judging, in order to optimise resources to validate international jury and events.

The OCSC, based on the EAWP End Of Term Report, recommends that "a full review of appointment procedures by the Board with reference to future World Sailing and Race Officials Strategy including a newly formed World Sailing Event Strategy" is undertaken, involving all stakeholders, to define a process and policies that work for all involved.
