## **1. Opening of the Meeting**

### *(a) Welcome by the Chairman*

The Chairman opened the meeting and welcomed the Sub-committee to Sanya

#### *Attendees and Apologies*

Apologies were received from Thomas Duggan (USA) Christophe Gaumont (FRA), and Athanasios Papantoniou (GRE).

### *(b) Obituaries*

*No obituaries were reported but respect was paid by the RMSC to race officials of other disciplines who sadly passed away during 2015*

## **2. Minutes of the previous meeting and Agenda**

### *(a) Minutes*

The Sub-committee noted the minutes of the Race Management Sub-committee meeting on 2 November 2014 (circulated and approved after the meeting).

### *(b) Matters arising*

There were no matters arising.

### 3. Budget

No issues reported by the Chairman. Competitions Manager discussed that 2016 budget is to be confirmed by the Executive Committee soon but is likely to be slightly higher due to the requirements within the discipline. The Instructor conference that will run in Feb was requested as a separate one-off item.

### 4. Tasks and Responsibilities – Reports

#### (a) Chairman's Report

Chairman welcomes VP Chris Atkins to the meeting. Sub-committee received a report from the Chairman including information on a vision of a pro-active committee that meets the expectations of sailors and all stakeholders at a high professional level

Chairman states issues/focuses for the future; strategic development in developing nations, appointment and assessment of education Instructors, Instructors conference, technology in race management; technology in starting and finishing procedures communication and procedures; improvement of internal communication to IRO community; linkage with coaches and sailors and other stakeholders; mentoring programmes.

#### (b) Working Group Reports

The Sub-committee received reports from the following working groups:

##### i) Manual Working Group

Chairman thanks HPH/CM for on-going work. Updated version of TR manual in progress, thanks to CA, also work on the kiteboarding manual BDW with comments being collected. Offshore work still ongoing. TD taking over from Ronnie McCracken to work on plan with HPH on updates for manuals.

##### ii) Regatta Documents and Forms Working Group

Thanks to TE who has done an outstanding job collecting these, they are available on the website. TE still some papers to be created so will be

NS suggests the idea to ask all classes to use the range of documents or make suggestions on improvement to create a set selection in use at high level events

Guidelines and policies discussed within SC in relation to major principle events, it important that any changes proposed by groups or working parties discussed with this group as experts in the field to help development forward

##### iii) Applications and Renewals

The review of these becoming better and better by SC, only issues are with some applicants not understanding the procedures/regulations. More strict and assertive instruction required within this area otherwise the admin becomes impossible especially with respect to deadlines.

TC brings up clarification of Race Officer role descriptions and definitions; document have been produced by CM for discussion, liaison needed with Olympic Classes on matching terminology to prevent issues on application forms especially.

Once definitions clarified a document is to be circulated with application form.

## Race Management Sub-committee Minutes (cont.)

Discussion may be needed on whether a change in regulation (2017) is needed on a second point of ITO role as qualifying criteria on application and ensure this is also reflected within the race management manual.

### iv) Regatta Reports

Ricardo Navarro (RN) presents on reports

RN suggests that the system of regatta reporting needs to be reviewed as well as what information that is being requested. TC recommends to ROC that a digital format is set-up. JN explains the expectation manage on the development of this.

### v) Appointments

SC received EAWP procedures, better transparency and continuity. To be discussed later in agenda

### vi) Newsletter/Communication

Continental ambassadors were introduced in 2014 to create connections between RMSC and MNA's/OA's to transfer information on education seminars, clinics, policies and procedures. Spread of training activity has shown this to be working and will continue to helping developing continents/countries

Decided in 2014 that a newsletter to be published every year – TD working on the next edition to be published soon (before the end of the year). MD to liaise with TD on this for circulation.

### vii) Coaches, Athletes and Other Committees

Still need to be proactive in this area through the SC members who are tasked to liaise and be involved in the feed of information back and forth between the groups.

TC brought up 3 items from a meeting with the coaches commission to be brought to attention of RMSC– registration system for coaches; clear space for coaches at medal races (not blocked by marshalls, spectators, media etc) to view races and performance; better access of documents on tablets; clear communication of radio channel usage at events.

### viii) Education; Seminars and Clinics;

3 seminar (2 Europe, 1 Asia), 5 clinics (2 Asia; 1 Europe; 1 S America; 1 Oceania; Africa clinic had issue with dates and hoped to be rescheduled for 2016)

Work on new materials for clinics has taken longer than expected but the conference in Feb 2016 should cover this area for work in developing regions

Allocation of clinics and seminars works well in terms of covering regions and the appointment of the instructors through availability and location. The assessment of Instructors and looking forward to potential training of new Instructors for the future discussed in more detail in the closed session.

JP notes on the success of clinics attached to events and how impressed he was with the reinforcement of the policies and practice during the event that followed.

TC agrees on the need to combine practical and theoretical alongside the training and development department. MD adds that the Secretariat has been working on introductions to officiating disciplines when connecting with MNA's at coach education level.

TC thanks TE for her work in readiness for the MNA Forum to promote race management clinics. TC asks for volunteers to attend with Tatiana, no volunteers initially come forward.

### **5. Race Management Procedures and Activities**

NS presented on numerical starting procedures. Subcommittee discussed merits/disadvantages of usage from SWC and the spiral downward to lower level regattas (document submitted by JP/NS). Chairman summarises that it is necessary to make changes to move forward in modern day sports with reference to media, spectators and other stakeholders. The responsibility is for a change to be clear and considered. Recommendation to follow procedures set a last Test Event in Rio which was successful. Final decision is with Technical Delegate (AF)

Standard list of race management equipment put together by JP, RN, NS sent to Alastair Fox and recommended to be used as an appendix to event organisers.

Format Working Party does not formally exist although work is underway with in the Events Committee looking with discussion on Tokyo 2020, RMSC involved in SWC in some technical areas of RM.

Chairman states issues/focuses for the future; strategic development in developing nations, appointment and assessment of education Instructors, Instructors conference, technology in race management; technology in starting and finishing procedures communication and procedures; improvement of internal communication to IRO community; linkage with coaches and sailors and other stakeholders; mentoring programmes.

### **6. Race Management Guidelines and Policies**

The Sub-committee made comments concerning the clarity of the policies in respect to amendments for particular events. If there is a need to change any policy at a venue there is quick communication between TD, PRO and Chairman. If there is a long-term need for change the RMSC will be involved in developing the guidelines.

Chairman proposes that the kit/equipment list is included in the RM Manual and as an attachment in contracts for principle events.

JN explains that the FR & MR policies have been approved. TR policies is awaiting approval from RMSC. TC asks for approval – all approve.

### **7. Event Appointments**

The Sub-committee note the report from the Event Appointments Working Party to the Race Officials Committee from Chairman Margriet Pannevis (MP).

Adrian Stoggall (AS) comments on how the timelines seem to have improved but that there is still a need for earlier appointment. CA adds that if the ROC agrees a roll out of a cross discipline grouping system that there is the possibility that senior members of a team are appointed more in advance.

### **8. Strategy and development**

Following discussion of other agenda items, the Chairman summarised the new strategic and development areas for the Sub-committee as being:

- (a) the holding of an Instructors' conference

Date confirmed in February 2016

- (b) the holding of an IRO conference in 2016

TC explains that after discussion with ROC chairman it is more likely that a conference for all disciplines would be organised. Discussion continues on the benefit of such a conference and clear subject areas.

## **Race Management Sub-committee Minutes (cont.)**

- (c) the development of a race management education and training programme in Japan to support Tokyo 2020;

TC discusses ongoing work on the timeline for preparations. Documents have been presented to ROC and EXC. A programme is being considered in regard to all disciplines with further information pending from JSAF on numbers and training provision. RM education programmes running in 2015 and will continue into 2016.

- (d) continuous education and development activities for IROs; and

Chairman recognises a need for Talent ID processes and asks for any help moving forward with this.

### **Recommendations not based on Submissions**

1. RMSC recommends that the IRO regatta report be changed to an online format and requests that ROC and the Secretariat allocate resources to this task.
2. RMSC recommends the numerical starting procedure trialled in the 2015 Olympic Test Event can be continued for the 2016 Olympic Sailing Competition and Sailing World Cup. It can be rolled out to other principal events but should not be used further without further evaluation.

3. RMSC recommends approval of the draft ISAF Team Racing Race Management Policies.
