

## Rio 2016 Olympic Sailing Competition

## SUPPLIED EQUIPMENT SCHEDULE AND PROTOCOL

Please note that these are guidelines only. Failure to observe these guidelines is not grounds for redress. For the rules regarding supplied equipment please see the Rio2016 NoR, SIs, Equipment Regulations and relevant Class Rules.

Date/Time	Notes
~13 July /	Equipment supplied will arrive at Sailing Venue
~13 to 23 July	Rio2016 staff with Neil Pryde (NP) and Laser Performance (LP) to unpack all equipment supplied outside the containers.
	A boat park with Lasers and a tent with RS:X should be created for this
	purpose. Rio2016 to check all equipment.
~13 to 23 July	Rio2016, LP and NP to make all equipment into "boat packs" with a
	random selection of equipment with all the supplied items of equipment
	as agreed. Each boat pack shall have the equipment serial numbers
	recorded and documented and sent to World Sailing for approval. Each
	boat pack will be labelled with a number 1,2,3,4,5 etc.
	For Laser/Laser Radial – the hiking strap should be made as part of the
	pack but not fitted.
	For RS:X – the NP fin, masts and boom shall be made as part of the
	pack. Spare equipment shall be securely stored with LP and NP and arranged
	in serial number order.
	Rio2016 to apply equipment limitation stickers on the correct location on
	the equipment under instructions from World Sailing.
23 July	Lock down day, no operation is possible at Sailing Venue.
24 July	World Sailing to check equipment boat packs and equipment limitation
	stickers.
25,26 July	Laser and RS:X random boat draw
Draw and	Rio 2016 shall make a public draw conducted by announcing the
Schedule	countries in alphabetical order and then randomly drawing a boat pack
Process	number. That number shall be recorded against the country for distribution later that day. World Sailing shall witness the public draw.
	Laser and RS:X equipment pick up schedule
	World Sailing shall create a schedule for a country to pick up their
	equipment after the draw has been conducted. The schedule shall list
	countries in alphabetical order. A group of countries will have a time slot
	of 1 hour to pick up their equipment. Only support team personnel from
	the specific nation may pick up the equipment.
	If a country turns up outside their time slot on the day of distribution they
	shall wait until there is availability to issue their equipment with priority
	given to those countries within the current time slot. If a country wishes
	to pick up their equipment outside the planned distribution day then they must contact the World Sailing equipment representative to arrange a
	time with LP or NP. The World Sailing equipment representative to arrange a
	be present whenever equipment is given to a team.
25 July	Rio2016 to make the public draw of Laser and Laser Radial equipment
10:00-11:00	supplied with national representatives (team leaders, coaches, sailors).
25 July	Rio2016 with World Sailing delivery of Laser and Laser Radial
12:00-18:00	equipment supplied by the pre-determined schedule.
	If an athlete wishes to use his/her own hiking strap the supplied hiking
	strap should be returned to LP and then only LP shall fix the athlete's
	hiking strap. If an athlete wishes to use his/her own deck mainsheet



	cam cleat the supplied cam cleat should be returned to LP and then only LP shall fix the athlete's cam cleat.
26 July 10:00-11:00	Rio2016 to make the public draw of RS:X equipment supplied with national representatives (team leader, coaches, sailors)
26 July 12:00-18:00	Rio2016 with World Sailing delivery of RS:X equipment supplied by a pre-determined schedule. Instructions:- If an athlete wishes to use his/her own mast, fin or boom then the NP supplied boat pack mast, fin and/or boom should be returned to NP and NOT given to the athlete. The serial number of any athlete mast, fin and/or boom shall be recorded at distribution and event limitation applied to the items of athlete equipment (a stamp with permanent ink is required for RS:X fins).
27 July to 4 August Equipment Replacements	If an athlete has an issue with his/her supplied equipment through a defect or a breakage then the Equipment Regulations apply and the following procedure shall be applied during the period from distribution to the arrival of the EIC (4 August):-  1. An equipment replacement form shall be completed by the athlete. These forms shall be available from the Sports Information desk.  2. The form should be then be given to the World Sailing Staff Equipment representative or the World Sailing Staff Technical Delegate.  3. The World Sailing representative shall then examine the damaged equipment and determine if a replacement is possible in accordance with the Equipment Regulations and Equipment Inspection policies. Equipment should only be considered for replacement in the event of breakage or a defect that is outside the building specification.  4. If approved (see #6) the equipment shall then be replaced with a spare from LP or NP. Spares shall be distributed in serial number order. The damaged item shall be taken from the athlete and the replacement shall have event limitation applied and all details shall be recorded on the equipment replacement form, including serial numbers.  5. Any broken or defective RS:X fins and masts (including those supplied by the athlete) shall only be replaced by NP supplied equipment. RS:X booms may be replaced by an athlete's own boom.  6. If there is doubt as to whether an athlete has broken a rule (such as deliberately mistreating the equipment) then the replacement should be referred by the World Sailing representative to the Chief Equipment Inspector and World Sailing Equipment ITO. If there is further doubt then the replacement shall be refused and the athlete asked to train with their own equipment until the EIC arrive and an EIC panel can be formed to determine the next step.
4 August EIC Arrival	Once the EIC has arrived then supplied equipment replacements shall be conducted within the normal Equipment Regulation and Equipment
	Inspection Policies framework.
